THE CUSTOMER AGREES TO ALLOW RIGHT OF ACCESS TO THE TOWN OF COLLIERVILLE AGENTS ON THE CUSTOMERS PREMISES AT ALL RESPONSIBLE TIMES AND PURPOSE. THE CUSTOMER ASSUMES RESPONSIBILITY FOR SERVICE BEGINNING FROM CONNECTION OR UNTIL THE TOWN OF COLLIERVILLE IS NOTIFIED OF CANCELLATION OF SERVICE. ALL BILLINGS RENDERED BY THE CUSTOMER SHALL BE DUE AND PAYABLE UPON RECEIPT. FAILURE TO RECEIVE A BILL DOES NOT RELEASE A CUSTOMER FROM PAYMENT OBLIGATIONS. THE CUSTOMER SHALL PAY ALL COLLECTION EXPENSES AND/OR ATTORNEY FEES DUE TO DEFAULT OR FAILURE TO PERFORM OBLIGATIONS INCURRED AS SET FORTH IN THIS AGREEMENT. IT IS AGREED BY THE CUSTOMER AND THE TOWN THAT THIS CONTRACT SHALL APPLY TO THE ORIGINAL ADDRESS OF THE CUSTOMER AND TO ALL FUTURE ADDRESSES OF THE CUSTOMER. INFORMATION SUBMITTED BY THE CUSTOMER TO THE TOWN OF COLLIERVILLE IN THIS AGREEMENT IS TRUE AND CORRECT TO THE BEST OF THE CUSTOMER'S KNOWLEDGE AND BELIEF.
